STRENGTHS:-

- Library is automated by 80%. Bar code of most of the books has been generated.
- ❖ Each department is equipped with a PC, a printer and an LCD projector to teach the students effectively with innovative teaching gadgets.
- The UGC XI plan budget is almost fully utilized for the purchase of books, sophisticated equipment, machinery to enhance congenial teaching, learning atmosphere.
- Periodical supervision of the Principal and faculty over the students.

WEAKNESSES:-

- Most of the students are from rural and economically backward communities hailing from families of agricultural families, fishermen and daily wage working classes. To motivate them to develop skills in them has become a tough task for the teachers.
- Class rooms are not properly ventilated and congenial for academic ambiance. Hence it is identified as another weakness.

OPPORTUNITIES:-

- The college has been located in the heart of the town and is nearer to the bus station and railway station. Hence the admissions are much satisfactory.
- ❖ The Government of Andhra Pradesh sanctioned the Jawahar Knowledge Center under the scheme Rajiv Udyogasri so as to develop skills, provide job opportunities and also unleash the potential of the students. It was started in 2008 and so far 400 students were trained up.

THREATS/CHALLENGES:-

- ❖ Many students are working in part time jobs during their leisure time for eking out their livelihood. Hence they are unable to concentrate on their academics.
- ❖ In B.A and B.Com courses many students from vocational background in intermediate join the college since they have no feeding college in vocational course at UG level. They too are not much associated with learning process.

- ❖ To improve admissions and infrastructure
- ❖ To take much care for the improvement of the results
- ❖ To work hard for the development of the institution
- ❖ The Department of History is planning to conduct an add-on course in disaster management.
- ❖ The Department of English is planning to conduct a certificate course.
- ❖ The Department of History is planning a diploma course in epigraphy.
- ❖ The institution is planning to conduct remedial coaching regularly for SC, ST, OBC, Minority Community students and academically weak students.
- ❖ The institution is planning to conduct Awareness Programs frequently on Savings, AIDS, Environment and Social responsibilities.
- ❖ The institution is planning to communicate Student Progress to the Parents by conducting Parent/Guardian meetings frequently.
- ❖ The institution is planning to conduct Seminars, Conferences, Workshops and other programs to improve the knowledge of the students.
- ❖ The institution is planning to computerize the examination wing completely.
- ❖ The institution is planning to conduct Coaching Classes for PG Entrance for the outgoing final year students.
