1. Parties :-

This Memorandum of Understanding (here in after referred to as "MOU")
is made and entered into by and between

b) Department of Chemistry, Government Degree College, Avanigadda,
Krishna District

2. Purpose :

- The purpose of this MOU is to promote and enrich teaching and learning process of the faculty of Party 1 and for the quality instructions for the Party 2.

3. Term of MOU :

- This MOU is effective upon the day and date signed and will be executed by the parties from April, 2022 and shall remain in full force and effect for not longer than 5 years. This MOU may be terminated, without cause, by either party upon two months written notice, which notice shall be delivered by hand or by certified mail to the address listed above.

4. Responsibilities of Parties :

- The faculty and students of Party 1 will teach/train the faculty and students of Party 2, so as to enrich the teaching experience of faculty and learning experience of students of the Party 2 as per the schedule resolved in the meeting held on 31-03-2022 in the Chamber of the Principal, Sri ABR Government Degree College, Repalle.
- The Party 2 may request some of the faculty or students of Party 1 to address the faculty or students of Party 2.
- Mere participation of faculty and students of Party 1 in teaching the faculty and students of Party 2 according to this MOU does not carry any right or any legal entitlement to demand for placement with Party 2.
- The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties.




